Notice of Project Change and Second Virtual Information Session

Mississauga Reinforcement Project

Enbridge Gas Inc. (Enbridge Gas) is proposing to construct new pipeline infrastructure in the City of Mississauga and Town of Oakville. The purpose of the project is to accommodate, in part, a transition from other fuel sources to natural gas for existing Enbridge Gas customers.

Enbridge Gas has conducted constructability and customer needs assessments for this project, and as a result there has been a change to the project scope. In addition to what has been previously shared, Enbridge Gas is proposing to construct an additional pipeline segment along Hazelhurst Road as part of the preferred route, as well as a feeder station at the intersection of Hazelhurst Road and Lakeshore Road East. The revised figure below now displays the revised preferred route, two alternative routes and two existing customer stations to be rebuilt on commercial customer property, as well as the feeder station.

Enbridge Gas has retained Stantec Consulting Ltd. to complete the Environmental Study for the project as part of the planning process. The Environmental Study will fulfill the requirements of the Ontario Energy Board's (OEB) "Environmental Guidelines for the Location, Construction, and Operation of Hydrocarbon Projects and Facilities in Ontario, 8th Edition (2023)".

It is anticipated that an Environmental Report for the study will be completed in December 2024, after which Enbridge Gas will file an application to the OEB to request a Leave to Construct for the project. Should the OEB find the project to be in the public's interest, construction is anticipated to commence as early as Q4 2026.

Public consultation is an integral component of the Environmental Study, and the process includes consultation and engagement with landowners, Indigenous communities, government agencies and other interested persons. A virtual information session will be held online to share details of this project change, as per the details below:

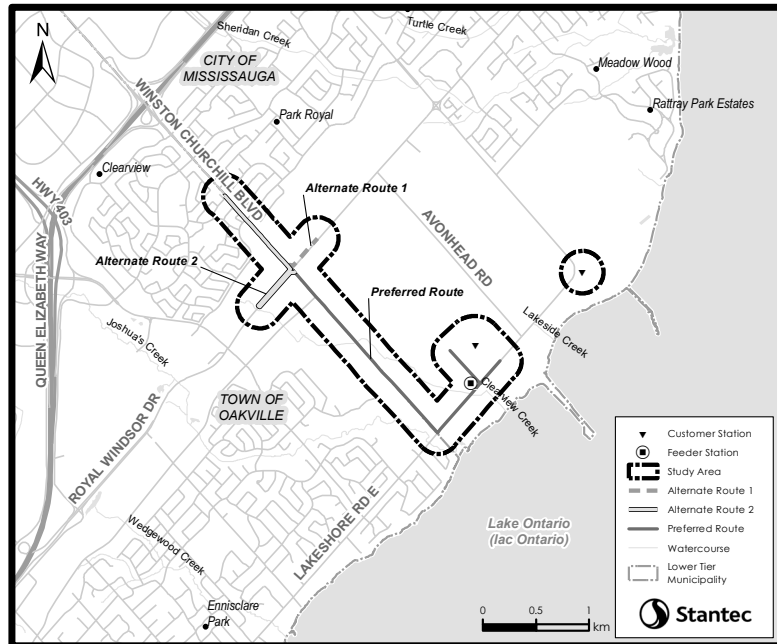
